**ORDER**

**Whereas**, Smt.Sangeeta Thakur, Lecturer (School-New) (English) was transferred from GSSS Shoghi (SML) to GSSS Dhami (SML) vide office order dated 12.02.2021. Smt.Sangeeta Thakur challenged these orders by filing CWP No. 770/2021 before the Hon'ble High Court. The case was finally listed before Hon'ble court on 27.11.2021 when the same was disposed of. The operative part of the order dated 27.11.2021 is as below:-

**“Learned counsel for the petitioner submits that without prejudice to the contention which were raised in the writ petition challenging the impugned transfer order, the petitioner will be satisfied in case this present petition is disposed of by directing the respondents-department to transfer the petitioner against any one of the following vacancies which are vacant or are likely to become available in immediate future on account of promotion. Three of said vacancies are:-**

1. GSSS Bisha.
2. GSSS Lal Pani
3. GSSS Chota Shimla.

**Learned counsel for the private-respondents submits that he has no objection in case the prayer of the petitioner so made is considered by this court.**

**Accordingly, taking into consideration the fact that the petitioner has now completed three years of service in the present place of posting, this writ petition is disposed of with the direction that the petitioner be transferred against a vacancy reflected in the above part of this order or against a vacancy which may become available in near future but definitely within a period of two weeks from today and till then status quo be maintained.**

**And whereas**, petitioner also submitted a representation and requested to adjust her as per directions of Hon'ble Court.


**And whereas**, after going through the record it is found that at present there is no vacancy of Lecturer (English) at GSSS Bisha (SLN), Lalpani (SML) and Chhota Shimla (SML) and also no Lecturer (English) was promoted from her choice of stations in the promotion list of Headmasters which was issued on 03.12.2021. However, Smt.Sheetal Sharma, Lecturer (English) from GSSS Bisha (SLN) and Smt.Kuntla, Lecturer (English) from GSSS Chhota Shimla is under the zone of promotion as Principal but it is not certain when promotion list will be issued.

**And whereas,** petitioner again submitted a fresh representation and requested to adjust her at GBSSS Lalpani (SML) vice Sh.Pratap Chand, Lecturer (School-New) (English) who is willing for his transfer to GSSS Halog (Dhami) (SML).

**Now therefore,** as per request of the petitioner, Smt.Sangeeta Thakur, Lecturer (School-New) (English) who is under orders of transfer from GSSS Shoghi (SML) to GSSS Halog (Dhami) (SML) is hereby adjusted at GBSSS Lalpani (SML) vice Sh.Pratap Chand, Lecturer (School-New) (English) who is hereby further transferred to GSSS Halog (Dhami) (SML) against vacancy, without TTA/JT to both with immediate effect. The due and admissible salaries also be paid to the petitioner and respondent No.3 within the aforesaid period.

With these observations, representation stands disposed of.


