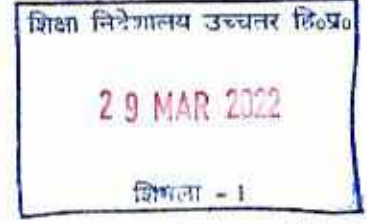


OFFICE ORDER
