## **ORDER**

Whereas the petitioner namely Smt. Santosh Kumari, Lect(History) was transferred from GSSS Auhar(Bilaspur) to GSSS Saloa (Bilaspur) vice Sh. Bansi Ram, Lect(History) by clubbing her previous stay on dated 21.12.2023. Feeling aggrieved against these orders she filed CWP No. 10738/2023 titled as Santosh Kumari vs State of HP before the Hon'ble High Court seeking there in relief, which was listed on dated 07.05.2024 when the learned councel for the petitioner seeks permission to withdraw this petition with liberty to approach the competent authority by filing a representation for her adjustment at places where the posts are lying vacant by suggesting such places in her representation.

> " Prayer being innocuous is allowed. Accordingly petitioner is permtted to withdraw the petition with liberty as aforesaid. In case, petitioner submits her representation, the same shall be decided by the competent authority within one week from the receipt of such representation."

And whereas, upon passing of above direction the representation from the petitioner has been received on dated 08.05.2024 and she has requested that she may be adjusted either at GSSS(B) Ghumarwin or GSSS Gallian or DIET Jukhala or GSSS Sohal in district Bilaspur

And whereas, as per the direction passed by the Hon'ble Court, request of petitioner has been considered and rejected on the plea that she has already served about five years stay within the radius on 30 Kms and now she should serve in GSSS Saloa(Bilaspur). Hence, transfer order issued dated 21.12.2023 shall stand.

Now therefore, after taking into account the above discussed detailed facts and circumstances, transfer order of the petitioner issued vide this Directorate office order No. EDN-H(26)B(6)13/2023-History dated 21.12.2023 shall stand and she is hereby directed to join at GSSS Saloa(Bilaspur). This order will not come in the way of MCC, already enforce in the State.
