ORDER

Whereas, Smt. Indrani Sharma, Lecturer (School-New) (Economics) has filed CWP No. 11462/2024 before the Hon'ble High Court for seeking her transfer from GSSS Khundian, Distt. Kangra to her choice of stations i.e. GSSS Dehan/GSSS Bhawarna/GSSS Rajpur/GSSS Palampur, Distt. Kangra on medical ground.

The case was finally listed before the Hon'ble High Court on 16.10.2024 when the case was disposed of with the following directions:-

"Learned counsel for the petitioner submits that with respect to the grievance being raised in the present petition, as appropriate representation stands filed by the petitioner. The same is appended along with the present petition as Annexure P-4."

And whereas, upon passing of above directions, petitioner has submitted a her fresh representation in reference to this office letter dated 10.12.2024 wherein she has given the same stations which is earlier submitted in her old representation but not opted any other vacant post.

And whereas, as per the direction passed by the Hon'ble High Court as above, the request of the petitioner has been examined and found that the petitioner has not opted any available vacancies and she opted against longer stay for her transfer which cannot be considered as it will lead another litigation. However, available vacancies were offered to her for her adjustment i.e. Malahari, Khanni, Ghamroor, Jachh, Thakurdwara (Indora), Seul, Gheen, Kandi-Dholran, Darini, Dhaneti, Amlela, Dainkwan, Minjgran, Lagru, Bhadpur, Mohtali, Sukhar, Sanhoon, Surani, Harchakian, Bathu-Tipri, Hatwas, Paisa, Amni, Badanj, Baroh, Bhali, Baranda, (G) Garli, Gharjarot, Gummer, Hatli, Kandwal, Andretta, Daroh, Rajiana-Bandh, Nangal, Rakh, Serathana, Kothi --Kohar.

Now therefore, after taking into account the above discussed detailed facts and circumstances, a request of the petitioner cannot be acceded to. Hence in view of ongoing facts, representation of the petitioner has been considered and rejected with the direction that she may represent a fresh after ~~opting~~ any other vacant post and till then she will continue at GSSS Khundian (Kangra).

With these observations, representation stands disposed of.
