## **ORDER**

Whereas, Sh. Neetu Chauhan, Lecturer (School-New) Geography has filed CWP No. 1373/2027 before the Hon'bel High Court regarding his transfer from GSSS Daya (SMR) to choice of his stations i.e. GSSS Guggaghat/ GSSS Kandaghat/GSSS Chamian, Distt. Solan and GSSS Sanora/GBSSS Nahan Distt. Sirmour as he has completed his normal tenure in hard area. The case was finally disposed of by the Hon'ble Court on 29.02.2024 with the following directions:-

"Faced with this situation, learned counsel for the petitioner prays for and is granted a week's time to make fresh representation in continuation of the earlier representation dated 24.10.2024 (Annexure P-1); with further directions to the Respondent No.2-Director Higher Education, Himachal Pradesh, Shimla, to consider/examine the representation dated 24.10.2023 (Annexure P-1) including the fresh representation intended to be file as aforesaid, and to pass appropriate orders in the light of Clauses 12, 15 and 16.1 of the Transfer Policy, within four weeks thereafter."

And whereas, upon passing of above directions, petitioner, Sh. Neetu Chauhan, submitted a representation and requested to adjust him at GSSS Guggaghat/GSSS Kandaghat/GSSS Chamian, Distt. Solan and GSSS Sanora/GBSSS Nahan Distt. Sirmour as he is suffering from stone problem as well as he has completed his normal tenure in hard area.

And whereas, as per the direction passed by the Hon'ble Court as above, a request of the petitioner has been considered and found that at present the post of Lecturer (Geography) is not lying vacant at GSSS Guggaghat/ GSSS Kandaghat/GSSS Chamian, Distt. Solan and GSSS Sanora/GBSSS Nahan Distt. Sirmour. Therefore, it is not feasible to adjust him at proposed stations.

**Now therefore,** after taking into account the above discussed detailed facts and circumstances, a request of the petitioner has been considered. Hence in view of ongoing facts, the petitioner Sh. Neetu Chauhan, is hereby transferred from GSSS Daya (SMR) to GSSS Darlaghat (SLN) against vacancy.



## With these observations, representation stands disposed of.
