ORDER

whereas, the contract appointment in education department was contrary to R&P Kules and candidate or local employment exchange participated in selection process and initially it was stopgap arrangement. whereas, Lecturer School cadre is state cadre. The Govt. after cabinet approval conveyed decision to regularized the service of those contractual who have complete 08 years of continues services as on 31.12.2004 from 01.01.2005 and those who are going to complete 08 years contract service as on 31.12.2005 w.e.f. 01.01.2006 however in approval it was mentioned that for contractual who will complete 08 years' service as on 31.12.2005 orders should be issued after 31.12.2005 i.e. regularization w.e.f. 01.01.2006. Thereafter Government had not given any approval to eguiarize the service of contractual till 09.09.2008. First time regularization policy for contractual was notified by DOP to the Government on 09.09.2008 and it was mentioned that those contractual who have complete 08 years services as on 31.03.2008 may be regularized after observing codal formatities. As per Govt. decision regularization granted to them after 08/09 years contract service itself is a generous gesture on the part of the Government since after regularization they have been given regular scale and is treated at par with omer regular employee. This generous gesture shown by the Government is in deviation of the normal channel of recruitment. These contractual have filed various CWP's before the Hon'ble High Court of Himachai Pradesh.

And whereas Smt. Arpana Ball was appointed as a temporary measure on "Contract Basis" by the Principal GSSS Girls Chamba District Chamba as Leet. Music (Vocal) and she joined on 12.11.1998. Her services were regularized by the department vide 6.150 dated: 02.03.2009. She has filed CWP No. 1853 of 2009-D before the Hon'ble High Court of Himachal Pradesh which was disposed of on 10.04.2013 is as under: -

"19. Accordingly, there shall be a direction to the 2"" respondent to order the regularization of the petitioner on notional basis w.e.f. 1.1.2007, within a period of two months from the date of production of a copy of this order by the petitioner before the 2"" respondent. However, the due and admissible monitory benefits be restricted from the date of she had joined duties pursuant to the office order dated 02.03.2009, Annexure P-13."

And whereas, the matter was under consideration with the Govt. under which it has been conveyed vide letter no. EDN-C-B(15)10/2015 dated 05.10.2019 is as under:-



"Examinea. Department is advised to settle the issue as per directions of the Hon'ble High Court. Further instructions dated 15.12.2011 and 07.01.2012 issued by Finance Department may also be kept in view by the Department.

Government and it has been conveyed vide letter no. EDN-B-E(5)-9/2020 dated 29.12.2021 is as under: -

The case of Arpana Bati was implemented as per the advice of the Law Department and Finance Department. The Director of Higher Education is directed to consider the case and decided the CWP No. 89/2020 titled as Anil Rana Vs State of H.P. and others as per the advice of the Law Department and Finance Department in Arpana Bati's case provided that the CWP No. 89/2020 titled as Anil Rana Vs State of H.P and other connected cases are similar to the case of Arpana Bati in CWP No. 1853/2009-D."

Now therefore, in compliance to Hon'ble court order in Ex. Petition No 109/2023 dated 28.06.2023 (CWP No 4556 of 2022) the case of Smt Jeet Kaur, Lect. Pol Sc.(Retd) GBSSS Una, HP and Hon'ble court order in CWP No 1982/2023 dated 17th April,2023 the case of Smt Bhawna Guleria, Lect. History GSSS Gohar (Mandi) HP, have been considered and examined in the light of Hon'ble court order dated 18.04.2013 in CWP No 1853/2009 titled as Arpana Bali vs State of HP & ors and found that both the petitioners being retrenened contractual not covered under judgment of Arpana Bali's case. However their claim is justified in light of LPA 145/2010 titled as Narain Singh vs State of HP. Accordingly regularization in r/o petitioners are hereby allowed at par with their junior as under:-
