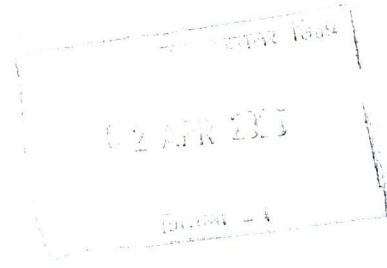

ORDER

Whereas, Sh. Promod Kumar, Lecturer (School-New) (Economics) presently posted at GSSS Sudhar (Mandi) has filed CWP No. 15075/2024 before the Hon'ble High Court for seeking his transfer from GSSS Sudhar, Distt. Mandi to his choice of stations i.e. GSSS Bassi/Matroo/Girls Joginder Nagar/Drubbal/Makreri against vacancy or longer stayee by clubbing their stay within the radius of 30 KM as he has completed his normal tenure in hard area as well as medical problems of the parents.

The case was listed before the Hon'ble High Court on 25.2.2025 when the case was disposed of with the following directions:-

“Consequently, in view of aforesaid fair stand adopted by learned Additional Advocate General, this Court without going into the merits of the case, deems it fit to dispose of the present petition with the direction to respondent to decide the pending representation (Annexure P-I), if not already decided, expeditiously, preferably, within a period of four weeks. Ordered accordingly. Needless to say, authority concerned while doing the needful in terms of instant order, shall afford an opportunity of being heard to the petitioner and pass detailed speaking order taking note of provisions contained in the transfer policy formulated by the Government, wherein admittedly provision has been made to consider cases for transfer on ground of medical condition of the parents. Liberty is reserved to the petitioner to file appropriate proceeding in the appropriate Court of law, if he still remains aggrieved.”

And whereas, upon passing of above directions, a fresh representation from the petitioner has been received on 19.3.2025 and perused which revealed that he has completed three years services at his present station. As well as his parents are in their old age and father is suffering from heart and uro problems.


And whereas, that the matter has been examined on the basis of report received from the Deputy Director of Higher Education, Mandi. Presently, the post of Lecturer (Economics) is only lying vacant at GSSS Matroo (Mandi) but it could not be given him due to some administrative reasons. However, Sh. Arjun Singh, Lecturer (School-New) Economics has been working at GSSS Makreri (Mandi) w.e.f. 5.10.2023. But prior to this he has posted at GSSS Chauntra (MND) w.e.f. 28.4.2016 to 15.7.2018, GSSS Makreri (MND) w.e.f. 16.7.2018 to 5.3.2021 and GSSS Bihun (MND) w.e.f. 6.3.2021 to 4.10.2023 and is working within a radius of 30 KMs w.e.f. 28.4.2016. The Govt. vide its letter No. EDN-B-B(16)-8/2017 dated 27.10.2023 has conveyed that “the continuous services rendered by employees of Education Department within the radius of 30 Kms will be considered stay/tenure at one station, & such services will be clubbed for calculation of tenure for purpose of transfers.”

Now therefore, in view of the facts narrated above, a representation of petitioner is considered sympathetically and the petitioner i.e. Sh. Promod Kumar, Lecturer (School-New) (Economics) is being transferred from GSSS Sudhar, Distt. Mandi to GSSS Makreri, Distt. Mandi without TTA/JT vice-versa Sh. Arjun Singh, Lecturer (School-New) Economics with TTA/JT.

With these observations, representation stands disposed of.
