**ORDER**

**Whereas**, Sh. Praveen Kumar, Lecturer (School-New) (English) has filed CWP No. 16113/2024 before the Hon'ble High Court for seeking his transfer from GSSS Barag, Distt. Sirmour to his choice of stations i.e. GSSS Boileauganj Distt. Shimla/GBSSS Arki/GSSS Haripur/GSSS Mangal/GSSS Saur, Distt. Solan as he has already completed his normal tenure in hard area.

The case was finally listed before the Hon'ble Court on 26.12.2024 when the case was disposed of with the following directions:-

**“This Writ Petition is accordingly disposed of with the direction that the representation filed by the petitioner be decided in light of the averments made therein within a period of four weeks from today. Pending miscellaneous application(s), if any also stand disposed of accordingly.”**


**And whereas**, upon passing of above directions, representation of petitioner has been examined and it is found that presently petitioner is not posted at GSSS Sangrah (Sirmour) as such he mentioned in his representation. Therefore, to decide the said CWP, petitioner was called to appear in person on dated 08.01.2024. During the course of hearing, petitioner said that presently he is posted at GSSS Barag (Sirmour) instead of GSSS Sangrah (Sirmour) and further requested to adjust him at GBSSS Arki (Solan) against vacant post.

**Now therefore**, after taking into account the above discussed detailed facts and circumstances, a request of the petitioner has been considered sympathetically and the petitioner i.e. Sh. Praveen Kumar, Lecturer (School-New) (English) is being transferred from GSSS Barag (Sirmour) to GBSSS Arki (Solan) against vacancy without TTA/JT..

With these observations, representation stands disposed of.
