ORDER

Whereas, the petitioner namely Ramesh Bhardwaj, Lect(SN)(Hindi) who is working at GSSS, Dhang-Ruhana (Sirmour) since 18.09.2022 has filed CWP No. 1801/2023 titled as Ramesh Bhardwaj vs State of HP before the Hon'ble High Court seeking there in relief regarding her transfer. This petition was listed on 05.04.2023 when the Hon'ble Court has directed that:-

"In the given facts and circumstances of the case, we deem it appropriate to dispose of this writ petition by directing respondent No.2/competent authority to consider and decide the representation made by the petitioner sympathetically, in light of the fact that daughter of the petitioner is suffering from cancer and is undergoing treatment at Ambala as also Chandigarh. The entire exercise be completed within two weeks. Ordered accordingly."

And whereas, upon passing of above direction the representation from the petitioner has been received on dated 06.04.2023. The petitioner vide her representation has requested for her transfer from GSSS Dhang-Ruhana(Sirmour) to GSSS(G) Paonta-Sahib (Sirmour) against vacancy being caused due to retirement of present incumbent on 30.04.2023. She has requested to consider her case sympathetically on medical grounds of her daughter being cancer patient as per direction of Hon'ble Court.

Now therefore, after taking into account the above discussed detailed facts and circumstances stated above, the request of the petitioner deserves sympathetic consideration on humanitarian grounds in light of the fact that daughter of the petitioner is suffering from cancer. Hence, the petitioner is hereby transferred from GSSS Dhang-Ruhana (Sirmour) to GSSS(G) Paonta-Sahib(Sirmour) against vacancy being caused due to retirement of present incumbent on 30.04.2023 without TTA/JT and these orders shall be come into force on or after 01.05.2023.

With these observations, representation stands disposed of.
