In continuation to this Directorate letters of even No. dated 7th May, 2022
and 27th May, 2022, on the subject cited above.

In this context, you are therefore directed to issue necessary directions to
the Principals / Headmasters of the schools mentioned in the Annexure "A" and "B" to strictly
follow the following measures:-

1. Appoint the Principals / Headmasters of concerned school as Nodal Officer regarding Harbal / AYUSH Garden established in their school.
2. The Principals / Headmasters will also appoint a senior most teacher of his /her school as coordinator, who will look after the Harbal / AYUSH Garden established in their school.
3. Share the Name, Designation, Mobile No. and E-mail address of the Nodal Officer with the AYUSH Department, Forest Department, and this Directorate.
4. The Nodal Officer will make liaison with the AYUSH Department and Forest Department for plantation during the rainy season.
5. All the Nodal Officer - cum - Principal / Headmaster of those schools, which are selected for setting up of Herbal / AYUSH Garden will get in touch with "**Sh. Ujjwal Deep Sharma, Incharge, Research Institution in ISM, Ayush Vibhag, Jogindernagar (Mandi), Himachal Pradesh, Phone No. 7018920221 and E- mail: incharge-ism-hp@nic.in**".
6. All the Principals and Headmasters will share the proper location / locality of their school i.e. Name of School, Place of School, Block, Tehsil, District Height and temperature of the area with the AYUSH Department and Forest Department for distribution of the plants.
6. Sensitization of the students about the Harbal Plants be ensured.
7. Display the vernacular (local name) and scientific name, use of the AYUSH / Harbal plant and its medicinal values.
8. The Nodal Officer and coordinator will ensure the survival of these plants by involving a group of the students regularly.
9. Provision of the tree guard be made.

10. The Principal / Headmaster will direct the next officer / teacher to look after the AYUSH / Harbal Garden on transfer, promotion or retirement of the coordinator.
11. The whole responsibility of AYUSH / Harbal Garden will vest on the Head of concerned school.

In this regard, you are also directed to issue necessary directions to the Heads of concerned school that the His Excellency Governor of Himachal Pradesh may visit any selected site to see the progress of planting trees, hence give your personal attention for survival of the plants. In view of the above, provide the details of Nodal Officer - cum - Principal / Headmaster of those schools which are selected for setting up of Herbal / AYUSH Garden in your respective District to this Directorate on the following performa, within two days positively:-
