"ORDER"

Whereas the petitioner Sh. Ram Nath, Lect./Lect.(SN) History is working at GSSS Sach(P), Distt. Chamba w.e.f. 12.07.2018 & as such his stay is complete. Now he is seeking his transfer to the station of his choice and filed CWP No 606/2021 titled as Ram Nath Vs State of H.P before the Hon'ble High Court. This petition was listed before Hon'ble High Court on dated 01.02.2021 when the same was finally disposed with the directions to respondents as under:-

"Consequently, this petition is disposed of with liberty to the petitioner to make fresh representation to the respondent/ authorities concerned giving five stations of his choice, which must be spread in more than one district, within two weeks from today, in the light of clause 16.1 read with clause 16.5 of the transfer policy. On receipt of such representation, the respondent/ authorities shall decide the representation of the petitioner, in the light of the transfer policy occupying the field, within two weeks. It is clarified that while deciding the representation of the petitioner the respondents shall consider the stations of choice of the petitioner as mentioned in his representation, subject to the condition that the incumbents posted there have completed their normal tenure of posting, in accordance with the transfer policy. In case none of them have completed the normal tenure then the office of the respondent/ authorities shall get in touch with the petitioner apprising him of vacant stations where the incumbents heve completed their normal tenure nad the possible places where the petitioner can be posted. Pending application(s), if any, are closed."

And whereas upon passing of above directions, the petitioner represented to the undersigned on dated 28.07.2021 along with the copy of the directions dated 01.02.2021 passed by the Hon'ble High Court, HP. He has requested for his transfer from hard Area to soft area in District Kangra against vacancy fall in future or against longer stay.

And whereas, as per direction passed by the Hon'ble High court as above, a request of petitioner has been examined and also perused the record and observed that at present there is no vacancy at the stations of his choice.

Now therefore, after taking into account the above discussed facts and circumstances of the case, the request of the petitioner has been considered and accepted to the extent that he may represent a fresh as and when the vacancy exists as per his choice of stations and same will be decided separately as per transfer policy. Accordingly his representation stand disposed of.
