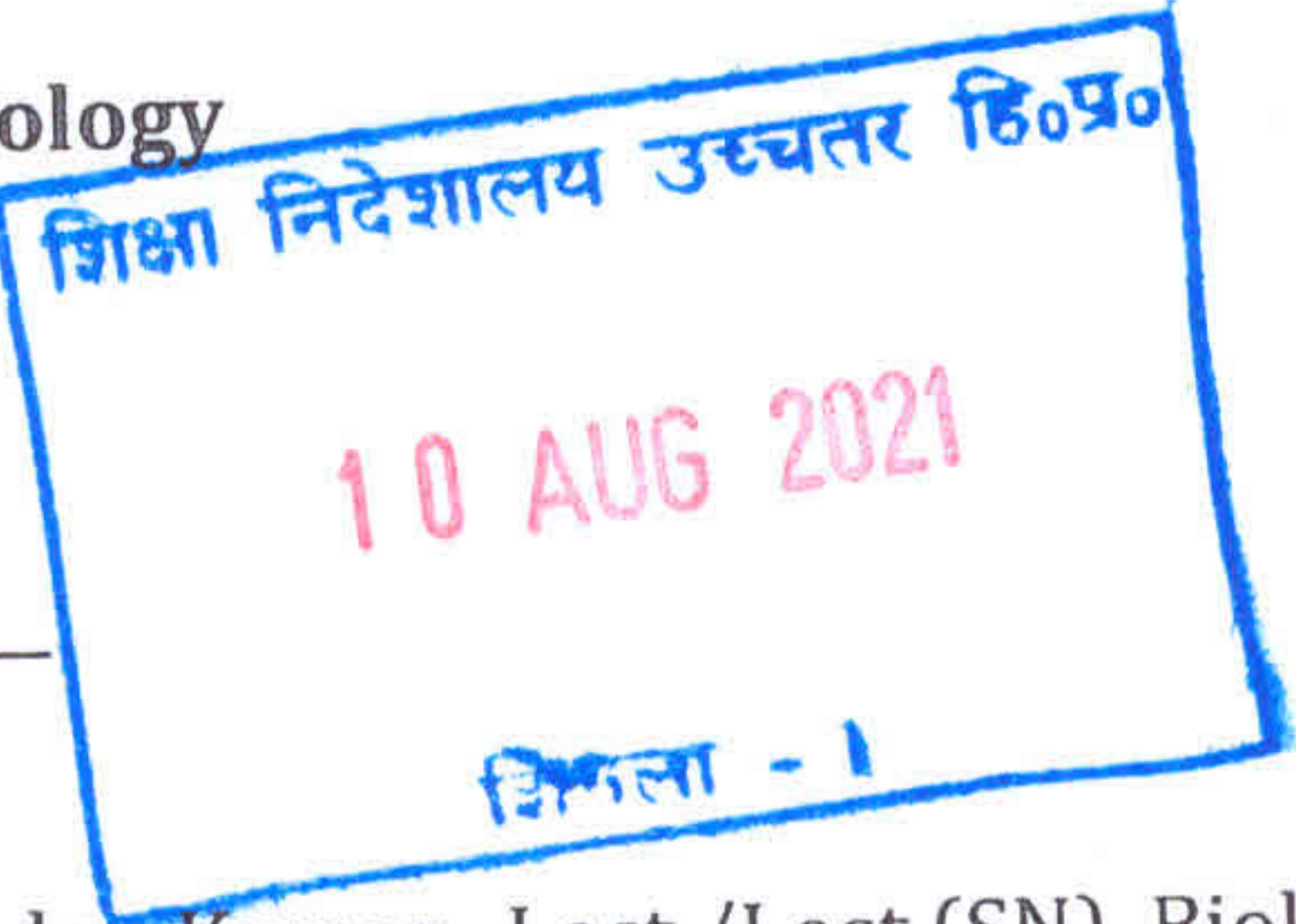

"ORDER"

Whereas the petitioner Sh. Virender Kumar, Lect./Lect.(SN) Biology is working at GSSS Nauradhar, Distt. Sirmour w.e.f. 22.09.2017 & as such his stay is complete. Now he is seeking his transfer to the station of his choice and filed CWP No 1348/2021 titled as Virender Kumar Vs State of H.P before the Hon'ble High Court. This petition was listed before Hon'ble High Court on dated 22.03.2021 when the same was finally disposed with the directions to respondents as under:-


"The petitioner has preferred the representation (Annexure-P3) dated 06.10.2020 for his transfer. The same has not been decided/ considered till date.

Without going into the merits of the case, we dispose of the petition by directing the respondents concerned to consider and decide the representation of the petitioner within a period of fifteen days from today. Pending application(s), if any, stand(s) disposed of."

And whereas upon passing of above directions, the petitioner represented to the undersigned on dated 15.07.2021 along with the copy of the directions dated 22.03.2021 passed by the Hon'ble High Court, HP. He has requested for his transfer from GSSS Nauradhar, Distt. Sirmour to the stations of his choice against likely to be vacated posts in GSSS Deothi, Distt. Solan, & GSSS Bhojnagar, Distt. Solan, H.P.

And whereas, as per direction passed by the Hon'ble High court as above, a request of petitioner has been examined and also perused the record and observed that at present there is no vacancy at the stations of his choice.

Now therefore, after taking into account the above discussed facts and circumstances of the case, the request of the petitioner has been considered and accepted to the extent that he may represent a fresh as and when the vacancy exists as per his choice of stations and same will be decided separately as per transfer policy. Accordingly his representation stand disposed of.


