Now he is seeking his transfer to the station of his choice and filed CWP No 1348/2021 titled as Virender Kumar Vs State of H.P before the Hon'ble High Court. This petition was listed before Hon'ble High Court on dated 22.03.2021 when the same was finally disposed with the directions to respondents as under:-

"The petitioner has preferred the representation (Annexure-P3) dated 06.10.2020 for his transfer. The same has not been decided/ considered till date.
