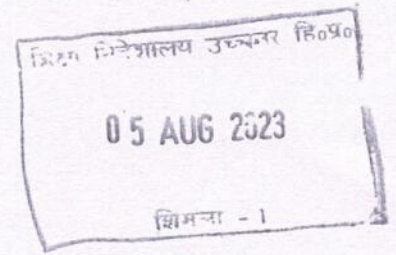

ORDER



Whereas, Sh. Neeraj Mahajan, Lecturer (English) was repatriated from O/o State Project Director, Samagra Shiksha, HP to his parent department and further transferred to GSSS Kanda Banah (SML) against vacancy vide this office order dated 24.06.2023 in compliance to CWP No. 6661/2021. Sh. Neeraj Mahajan, filed CWP No. 4891/2023 before the Hon'ble Court against this transfer. The case was finally listed before the Hon'ble Court on 31.07.2023 when the case was disposed of with the following directions:-

"This writ petition is disposed of by permitting the petitioner to make a representation to respondent No.2/competent authority within four days from today, which shall be considered and decided by respondent No. 2/ competent authority in accordance with law and applicable policy, within a period of ten days thereafter. The decision so arrived at shall also be communicated to the petitioner. Till such decision is taken, the petitioner shall not be compelled to join at the transferred place. He shall be at liberty to avail leave of the kind due".

And whereas, upon passing of above directions, petitioner, Sh. Neeraj Mahajan, Lecturer (English) submitted a representation and requested to adjust him either at GSSS Patukhar, GSSS Manjhol (SLN), GSSS Patta Brawari (SLN) or GSSS Kiar (SML) against vacancy or I may kindly be adjusted in DIET Shimla at Shamlaghat against any vacant post till March 2024.

And whereas, as per the direction passed by the Hon'ble Court as above, the request of the petitioner has been considered and found that at present the post of Lecturer (English) is not lying vacant at proposed stations except GSSS Kiar (SML).

Now therefore, after taking into account the above facts and circumstances of the case, representation of petitioner is considered and Sh. Neeraj Mahajan, Lecturer (English) who is under orders of transfer from the O/o State Project Director, Samagra Shiksha, HP to GSSS Kanda Banah (SML) is adjusted in GSSS Kiar (SML) against vacant post.

With these observations, representation stands disposed of.
