that there is no court case—before relieving /joining the above said officials. It will be ensured that in the event of a teacher to ag transferred, the transferred teacher shall join duty only when the person occupying the post is relieved first, only thereafter, the joining of the incumbent shall be accepted. In the event of the transfer of controlling officer himself he/she shall be deemed relieved on the submission of joining report by the other incumbent. If the controlling officer does not comply with this procedure, the salary of the surplus incumbent will be drawn from the salary of the controlling officer. It may also be ensured that in case of transfer in r/o NCC ANO, these orders may not be implemented and intimate this Directorate immediately.
