## ORDER

Whereas, the petitioner namely Sh. Jasbir Kumar, Lecturer(History) who was transferred from GSSS Kakriar (Hamirpur) to GSSS Tourkhola (Mandi) has filed CWP No. 2354/2023 titled as Jasbir Kumar vs State of HP before the Hon'ble High Court seeking there in relief regarding his adjustment at GSSS Bohni (Hamirpur). This petition was listed on 27.04.2023 when the Hon'ble Court has directed that :-

"In view of above submission, present petition is disposed of with a direction to respondent No. 2 to decide representation, dated 19.04.2023 by passing a speaking and reasoned order after affording an opportunity of hearing to the petitioner, if desired so.

Till decision of respondent No., the petitioner who has already been relieved from the present place of posting shall not be compelled to join at the next place of posting and he shall be at liberty to avail the leave of kind due."

And whereas, upon passing of above direction the representation/request of the petitioner dated 19.04.2023, vide which he has requested that due to his adverse family circumstances he is not able to join at GSSS Taurkhola (Mandi), moreover he has not completed his normal stay of three years at GSSS Kakriar (Hamirpur) and he has requested to adjusted him either at GSSS Bohni (Hamirpur) or GSSS Badhani(Hamirpur) against vacancy or any other place in Distt. Hamirpur. While considering the representation of petitioner it has been found that the post of Lecturer History is not lying vacant at GSSS Badhani(Hamirpu) and approvals from the competent authority has been received regarding transfer of Lecturer History to GSSS Bohni(Hamirpur) hence, cannot be considered and at present there is no other vacant post of Lecturer History in Distt. Hamirpur. However, request of the petitioner is allowed/considered to GSSS Chamboh (Hamirpur) against vacancy being caused due to retirement of present incumbent on 31.05.2023.

Now therefore, after taking into account the above facts and circumstances of the case, request of the petitioner has been considered and the petitioner Sh. Jasbir Kumar, Lecturer History who is u/t from GSSS Kakriar(Hamirpur) to GSSS Tourkhola (Mandi) is hereby adjusted at GSSS Chamboh (Hamirpur) against vacancy being caused due to retirement of present incumbent on 31.05.2023 without TTA/JT. These orders shall come into force on or after 01,06.2023. With these observations, representation stands disposed of.
