ORDER

Whereas, the petitioner namely Sh. Deep Singh, Lect(SN)(History) who is working at GSSS, Soma- Nachani (Mandi) since 27.08.2019 has filed CWP No. 2859/2023 titled as Deep Singh vs State of HP before the Hon'ble High Court seeking there in relief regarding his transfer to station of his choice as he has already complete more than three years in his present place of posting, which falls in sub cadre area. This petition was listed on 22.05.2023 when the Hon'ble Court has directed that :-

“In the aforesaid circumstances, the petition is permitted and directed to submit a fresh detailed representation by mentioning the stations of his choice to respondent No. 2 Director Higher Education and in case, such representation is preferred on or before 29.05.2023, the same shall be decided by respondent No. on or before 12.06.2023, by passing an appropriate speaking and reasoned order in accordance with Rules, Policy and law as applicable.”

And whereas, upon passing of above direction the representation from the petitioner has been received on dated 30.05.2023. The petitioner vide his representation has requested that he has already completed his normal tenure in difficult/hard area so he may be transferred from present place of posting to his choice of station i.e. either to GSSS Siun (Mandi) or GSSS Gahang (Mandi) or GSSS Ootpur (Mandi) against vacancy.

Now therefore, after taking into account the above discussed detailed facts and circumstances stated above, the request of the petitioner has been considered. Hence, the petitioner Sh. Deep Singh, Lect(SN) (History) is hereby transferred from GSSS Soma-Nacani (Mandi) to GSSS Gahang (Mandi) against vacancy without TTA/JT.


With these observations, representation stands disposed of.


