

In continuation to this office order No. EDN-HE (12) B (6)-21/2020-Promotion-I dated 06.09.2021 & 16.09.2021 vide which the promotion orders in r/o PETs to the post of DPEs and withdrawal orders from the post of DPE have been issued by this Directorate of Higher Education H.P.

Now therefore, On the recommendations of the Departmental Promotion Committee, in its review meeting, the following in-service PETs are hereby promoted as DPE (Diploma Holder in Physical Education) on regular basis in the pay scale of Rs. 10300-34800 + Grade Pay 3600 and posted in Govt. Sr. Sec. Schools as shown against their names subject to the conditions that no complaint/inquiry/vigilance case and disciplinary proceeding are pending against the individual concerned:-

The above promotion as mentioned from Sr. No.1 to 7 are subject to the condition that if the above promotes are not found eligible for promotion at a later stage (i.e. seniority dispute/qualifications and as a result of reservation to a particular category and due to disciplinary proceedings etc.) he/she will have no objection for being reverted to his/her original post of PET.

The Promotee will join their new place of posting on or before 21.09.2021 positively failing which promotion orders as DPEs shall deemed to have been withdrawn automatically for one year or next DPC whichever is later. No specific orders with reference to withdrawal of promotion orders will be issued separately. No extension will be available in any case for joining.



However, the promotion of above mentioned PETs to the post of DPEs is subject to the final outcome of CWP No.4716/2021 titled as Rajinder Kumar & Ors Vs state of H.P. and any subsequent orders passed by Hon'ble High Court in the above mentioned CWP.

The financial benefits will be admissible from the date of joining the post of DPEs. He/She will be entitled TA/DA and joining time as admissible under the Rules. Official who want to get their pay fixed according to the option, he/she will have to exercise their option within one month from the date of joining the promotional post. In case incumbent has been transferred the present Head Master/Principal wherever he/she is posted will relieve the promote after verifying the service particulars of the candidates. Those who have been posted outside the sub cadre/Tribal area will have to serve in difficult sub cadre area as and when the vacancy occurs in Tribal/Sub cadre Area.

Necessary intimation to this effect is furnished to this Directorate as well as to the institution where he/she is posted. It will be the sole responsibility of the concerned Principal/Headmaster to ensure availability of option not to join/relieving orders within a week's time after the stipulated period to this Directorate as well as to the institution where he/she is posted. It will be the sole responsibility of the concerned Principal/Headmaster to ensure availability of option not to join/relieving orders within a week's time after the stipulated period to this Directorate as well as concerned D.D.E.

Principal of the concerned school is requested to scrutinize the academic/professional and SC/ST certificates of the individual concerned at the time of joining and joining report be sent to this Directorate immediately. In case the concerned promote does not report for duty in the school with in the stipulated period, the matter may be reported so that next in panel could be promoted. They will ensure that the instructions issued on the subject are strictly adhered to in letter will ensure the submission of joining/Non joining report within a week's time after the expiry of the stipulated period.
