“OFFICE ORDER”

In pursuance of the decision arrived in Execution Petition No.86/2023 in CWP No.342/2021- titled as Yashwant Singh V/S State of H.P.& another and approval received from Govt.of H.P. vide Notification No.Edu-A-EOO5/4/2023 dated 23.01.2024 and in continuation of Govt.Notification dated 17.10.2023, the services of following PTA provided Assistant Professors (College Cadre) are regularized w.e.f.01.04.2018 in the pay scale of Rs.15600-39100+ 6000(GP)(pre-revised) per month, who are similiarly situated to Yashwant Singh V/S State of H.P.& another.The consequential monetary benefits to the petitioners will be released as per Hon,ble Court order dated 13.09.2023 in Execution Petition No.86/2023 i.e. 40% of arrears payable according to re-revised scale was to be paid by 31.12.2023 as such be paid immediately and remaining 60% arrears in two equal annual installments may be paid by 31.12.2024 and 31.12.2025 by calculating difference of pay of the petitioners,on the basis of pre-revised pay scale for the period from 01.04.2018 to till the earlier date of regularization.It is further directed that arrears on the basis of revision of pay scale shall be paid, as per the instructions issued by the Finance Department ,H.P.letter No.Fin-E-1-C(17)-6/08 dated 07.01.2012 and vide Letter No.Fin-(PR)B(7)-1/2021-Loose dated 17.09.2022:
