"ORDER"

Whereas the petitioner Sanjeev Singh Chhiber, Lect./Lect.(SN) Chemistry is working at GSSS Deha (Balson), Distt. Shimla w.e.f. 24.05.2016 & as such his stay is complete. Feeling aggrieved he filed CWP No 3909/2022 titled as Sanjeev Singh Chhiber Vs State of H.P before the Hon'ble High Court. This petition was listed before Hon'ble High Court on dated 20.06.2022 when the same was finally disposed with the directions to respondents as under:-

"Record reveals that prior to filing of the instant petition, the petitioner has made a representation dated 02.05.2022 (Annexure P-1) for his transfer.


Therefore, in the given facts and circumstances of the case, we deem it appropriate to dispose of this petition by directing the respondents to consider and decide the representation strictly in accordance with law within a period of four weeks from today.

The petition stands disposed of in the aforesaid terms, so also pending applications, if any.

And whereas upon passing of above directions, the representation of petitioner dated 02.05.2022 has been perused and examined and it has been observed that he has requested for his transfer either at GBSSS Theog, Distt Shimla against the present incumbent i. e Sh. Adarsh Sharma, Lect./Lect.(SN) Chemistry cum NCC Officer.

And whereas, the incumbent posted at GBSSS Theog, (SML) as NCC Officer, although the petitioner also serving as NCC Officer at present place of posting, as per transfer policy the incumbent posted at the stations of choice of the petitioner cannot be transferred in short stay. However he can be transferred any where against available vacancy if he opt for the same.

Now therefore, after taking into account the above discussed facts and circumstances of the case, the request of the petitioner has been considered and rejected to the extent that he may represent a fresh as and when the vacancy exists as per his choice of stations and same will be decided separately as per transfer policy. Accordingly his representation stand disposed of.


