## **ORDER**

Whereas, in compliance of judgment passed by the Hon'ble High Court in 3913/2023 titled as Kavya Sinha vs State of HP dated 18.07.2023, it was directed to respondent 2 and 3 i to jointly take a fresh call in the matter regarding transfer of all the concerned parties including the contesting parties to the lis and fresh exercise be carried out by the competent authority in accordance with law and taking into consideration the relevant policy/ instructions/ guidelines on the subject, within ten days from today.

Now Therefore, in compliance to the orders passed by the Hon'ble High Court of H.P. in CWP No. 3913/2023 titled as Kavya Sinha vs State of HP dated 18.07.2023 and after discussion with State Project Director, NOC given by the State Project Director, Samagra Shiksha(SS) Himachal Pradesh, respondent No. 1, vide his letter No. EDN-HPSES(ISSE)-CWP No. 3913/2023 dated 27.07.2023, the petitioner Smt. Kavya Sinha, Lect(Hindi) who is under transfer from DIET Nahan (Sirmour) to DIET Shamlaghat (Shimla) is hereby further adjusted at DIET Nahan (Sirmour) against the vacant post of Lecturer English till the Lecturer who fulfill the eligibility criteria for this post without TTA/JT. The said official can also be repatriated to her parent department at any time as per requirement of the department and as well as in the interest of the students.
