Whereas the petitioner Smt. Shanti Devi, Lecturer(SN) Hindi is working at GSSS Drabil (Sirmour) w.e.f. 07.09.2022 has filed CWP No 4099/2023 titled as Shanti Devi Vs State of H.P before the Hon'ble High Court regarding her transfer. This petition was listed before Hon'ble High Court on dated 26.06.2023 when the Hon'ble Court has directed to decide the representation of the petitioner. The operative part of this petition is as under:-

"Within three weeks, respondent No. 2 shall decide petitioner's representation dated 05.12.2022 and communicate his decision to the petitioner."

And whereas upon passing of above directions, no fresh representation has been received from the petitioner, however with the perusal of earlier representation dated 05.12.2022 it has been found that at present the post of Lect(Hindi) is not lying vacant in GSSS Birla and GSSS Tokion (Sirmour) the stations opted by the petitioner. Moreover, as per transfer policy the incumbent working in difficult/tribal/hard area will have an option of five stations of choice which will be for more than one District and as far as possible, efforts will be made to post them in any one station of their choice of the category of station in which he/she has not served earlier. But the petitioner has not given any fresh representation with any other station.

And whereas, after going through the record it has been found that the petitioner has joined at GSSS Drabil (Sirmour) on promotion as Lec.(SN)(Hindi) on 07.09.2022 and having very short stay and prior to her promotion she has already served at GSSS Tokion (Sirmour) as TGT w.e.f. 05.03.2021 to 07.09.2022. Moreover, earlier she has served more than ten years of her services within the radius of 30 Kms and in Paonta-Sahib Constituency since 2005 which is not more than 35 Kms.

Now therefore, after taking into account the above discussed detailed facts and circumstances, the request of the petitioner can not be acceded to. Hence, representation is hereby rejected to the extent that she may represent a fresh as per transfer policy, which will be decided separately as far as possible and till than she will continue at GSSS Drabil (Sirmour). With these observations, representation stands disposed of.
