**ORDER**

**Whereas**, Smt. Santosh Devi, Lecturer (School-New) (English) has filed CWP No.5813/2023 before the Hon'ble High Court regarding decide her representation dated 03.04.2023 vide which she has requested to transfer her from GSSS Sataun, Distt. Sirmour to nearby Paonta Sahib or GSSS Batamadi, Distt. Sirmour against vacancy.

The case was listed before the Hon'ble Court on 25.05.2023 when the case was disposed of with the following directions:-

**"In view of above submission, the instant writ petition is disposed of by directing respondent No.2/competent authority to consider and decide the aforesaid representation of the petitioner, in accordance with law and applicable Transfer Policy within a period of three week from today. The order so passed be also communicated to the petitioner. Pending miscellaneous application(s), if any, shall also stand disposed of."**

**And whereas**, upon passing of above directions, the representation made by the petitioner dated 03.04.2023 was not received this office till 12.09.2023. Therefore, petitioner was informed through telephonically as well as letter issued vide this office dated 12.09.2023 to submit her fresh representation. Thereafter, petitioner has submitted her fresh representation on 13.09.2023 but in the meantime her old representation has also received by this office on 13.09.2023 vide which she has requested to adjust her nearby Paonta Sahib or GSSS Batamandi (SMR).

**And whereas**, as per the direction passed by the Hon'ble Court as above, the request of the petitioner has been considered and found that at present the post of Lecturer (English) is not lying vacant at nearby Paonta Sahib and GSSS Batamandi (SMR).

**Now therefore**, after taking into account the above discussed detailed facts and circumstances, the request of the petitioner cannot be acceded to. Hence in view of ongoing facts, representation of the petitioner has been considered and rejected.

With these observations, representation stands disposed of.
