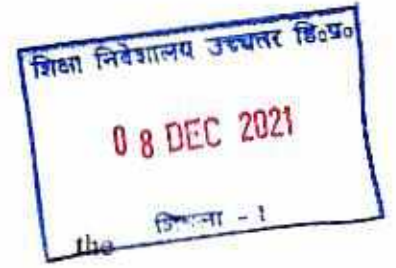

ORDER

Whereas, Sh. Kishori Lal, Lecturer (School-New) (Hindi) has been posted at GSSS Sanjauli (SML) since 13.03.2020 on temporary deputation on medical grounds with regular posting at GSSS Sunni (Sml) w.e.f. 31.03.2021. He filed CWP No. 5830/2021 for seeking relief to the effect that he may be transferred to the institutions in proper Shimla on medical grounds. The case was finally listed before Hon'ble Court on 29.11.2021 when the case was disposed of. The operative part of the said judgment is as below :-

“ We note that some of the incumbents have been posted in and around Shimla in the radius of 45 Kms probably from the time of their initial appointments and, therefore, they are liable to be transferred so as to replace and accommodate the other employees, more particularly , the petitioner as also private respondent No. 3.

Accordingly, we dispose of the instant petition by directing the official-respondents to accommodate both the petitioner as also private respondents No 3 in Shimla by transferring the incumbents with longest stay at Shimla and report compliance before the next date. Till then, the interim order dated 22.09.2021 to continue”.

And whereas, after examining the service particulars of Lecturer (Hindi) posted in and around Shimla, following Lecturers were found posted within the radius of 45 Kms around the Shimla maximum time of their entire service :-

Apart from this there are some others institutions near by Shimla such as GSSS Baldeyan, GSSS Mashobra and GSSS Shamlaghat (Sml) where the officials working as Lecturer(Hindi) has served above 17 to 18 years within the periphery of proper Shimla since their appointment in Education department.

And whereas, the respondent No. 3 Smt. Hem Lata, Lecturer(School New) (Hindi) has joined in Shimla on Navember, 2019 on temporary deputation basis and on regular basis in GSSS Sanjauli (Sml) w.e.f. 01.08.2020 , accordingly she has completed only 2 years stay in and around Shimla and having short stay.

Now therefore, after taking into consideration all the facts and circumstances of the case it has been found that, Smt Hem Lata Lecturer (Hindi) posted in GSSS Sanjauli (Sml) having short stay in Shimla and one Smt Varsha Sood Lect in Hindi has served approx 29 years 1 month in and around the Shimla during her entire service and by virtue of her incumbency she is longest in stay. Accordingly Smt Varsha Sood Lecturer in Hindi is hereby transferred from GSSS Bhattakuffer (SML) to GSSS Suni (SML) with TTA/JT vice Sh Kishori Lal Lecturer (SN) in Hindi without TTA/JT and vice-versa with immediate effect.

With these observations, representation stands disposed of. .
