## ORDER

Whereas, Smt.Deepika, DPE was repatriated to her parent department and posted at GSSS Bharog - Baneri (SMR) against vacancy and Sh.Nagender Singh, DPE was transferred from GSSS Kathwar (SMR) to DIET Nahan in place of vice Smt.Deepika, DPE vide office order dated 03.02.2023. Smt.Deepika, DPE filed CWP No.599/2023 against her repatriation orders in which Hon'ble Court has observed that petitioner has been transferred on the recommendation of the Public Representative of the area. Hon'ble Court has also mentioned an order passed on 10.08.2021 in CWP No. 3699/2021 whereby the transfer order of the petitioner was quashed on the ground that the same was passed in pursuance to a D.O note. In view of observation of Hon'ble High Court, transfer orders dated 03.02.2023 were cancelled vide office order dated 14.02.2023.

Whereas, Sh.Nagender Singh, DPE filed CWP 716/2023 agianst his cancellation of transfer orders dated 14.02.2023, which was listed before Hon'ble Court on 22.02.2023 when the case was disposed of with the following directions:-

"Respondent No. 2 is directed to afford an opportunity of hearing to the petitioner as well as private respondent 3 with a purpose to hear their respective grievances and hardships within a week from today. Respondent No. 2 will take a decision on the respective grievances of petitioner and respondent No. 3 within a week thereafter."

And whereas, upon passing of above directions, petitioner, Sh.Nagender Singh, DPE submitted a representation and requested to adjust him at DIET Nahan against the post of DPE as has been serving in far flung/hard areas since last nineteen years and also in view of his family circumstances. Accordingly, petitioner and respondent No.3, Smt.Deepika were directed to appear in person in Directorate of Higher Education, HP, Shimla-1 on 06.03.2023. On the fixed date, both were present and were heard in person. During the course of hearing, both (petitioner and respondent No.3) requested to post/retain them in DIET Sirmaur at Nahan.

Now therefore, after going through the record it is found that Smt.Deepika, DPE has been working at DIET Sirnmaur at Nahan since 31.07.2017 and she always served in or around Nahan city throughout her service whereas Sh.Nagender Singh, DPE has been serving in far flung/hard areas since last nineteen years. Hence, in view of forgoing

facts, Smt.Deepika, DPE is hereby repatriated with TTA/JT to her parent department and posted at GSSS Bharog - Baneri, Distt.Sirmaur against vacancy and Sh.Nagender Singh, DPE is hereby transferred on secondment basis, without TTA/JT from GSSS Kathwar, Distt.Sirmaur to DIET Sirmaur at Nahan, Distt.Sirmaur against resultant vacancy due to repatriation of Smt.Deepika, DPE with immediate effect.

With these observations, representation stands disposed of.
