**"ORDER"**

**Whereas** the petitioner Sh. Hem Raj, Lect./Lect.(SN) Maths was transferred from GSSS Rohanda, Distt. Mandi to GSSS Katwachi, Distt. Mandi vice Sh. Dom Singh, Lect./Lect.(SN) Maths, who is further transferred to GSSS Nihri, Distt. Mandi vice Smt. Rekha Devi, Lect./Lect.(SN) Maths, who is further transferred to GSSS Rohanda, Distt. Mandi & vice versa, with TTA/JT. Feeling aggrieved he filed CWP No 6283/2024 titled as Hem Raj Vs State of H.P before the Hon'ble High Court. This petition was listed before Hon'ble High Court on dated 05.07.2024 when the same was finally disposed with the directions to respondents as under:-

**"Learned counsel for the petitioner submits that the petitioner has filed a representation dated 16.06.2024 (Annexure P-1) with the respondent- Department and this petition be disposed of by directing the competent authority to take appropriate decision thereupon within some time bond period.**

**This writ petition is accordingly disposed of with the direction that the representation (Annexure P-1) filed by the petitioner, be decided sympathetically in light of the averments made therein, within a period of six weeks from today. Pending miscellaneous application(s), if any also stand disposed of accordingly.**

**And whereas** upon passing of above directions, the representation which has come through counsel on dated 12.08.2024 has been perused and examined and it has been observed that he has requested for his transfer either at GSSS Hatgarh,(Mandi)/ GSSS Rajgarh, (Mandi)/ GSSS Boys/ Girls Sundernager, (Mandi) against vacancy or is going to vacant very shortly due to promotion/ retirement or longer stayee by clubbing short stay distance.

**And whereas**, now therefore, after taking into account the above discussed facts and circumstances of the case, the request of the petitioner has been considered and rejected and his transfer order earlier issued on dated 31.07.2024 to GSSS Katwachi, Distt. Mandi shall stand. Accordingly his representation stand disposed of.
