In CWP No. 6403 of 2024 titled as Manorma Devi and another vs the State of Himachal Pradesh.

OFFICE ORDER

Whereas, the Principal Secretary Education to the Government of Himachal Pradesh conveyed the approval to fill up 1404 posts of Lecturer (School cadre) in various subjects on contract basis vide Letter No.EDN-A-Kha(1)-/2005-L dated 11.07.2008 and 23.09.2008. The requisition was placed to recruiting agencies on 11.08.2008 and 03.10.2008.

And whereas, these posts were advertised by the Himachal Pradesh Subordinate Service Selection Board Hamirpur vide advertisement No. 13/2008 dated 28.08.2008 and advertisement No. 14/2009 dated 17.02.2009. The provision of contract appointment was notified in R&P Rules of Lecturer (School Cadre) on 25.06.2009. Feeling aggrieved Smt. Manorma Devi Lecturer Hindi and Sh. Parkash Chand Lecturer History have filed CWP No. 6403 of 2024 titled as Manorma Devi and another vs the State of Himachal Pradesh & others. wherein The Hon'ble High Court on dated 09.07.2024 has ordered as under: -

"Learned counsel for the petitioners submits that the petitioners have filed representations with regard to the issue raised in the petition, but the same has not been decided by the Authority concerned till date.

This petition, accordingly, as prayed for, is disposed of with the direction that let representations of the petitioners be decided, in the light of the averments made therein as the judgment being relied upon by the petitioners, within a period of four weeks' by the Competent Authority. Pending miscellaneous applications, if any, also stand disposed of".

And whereas, the matter was taken up with the Government and on 08.01.2025 it has been conveyed to allow benefit qua the petitioners of CWP No. 6403 of 2024 only subject to final outcome of legal remedy and HP Recruitment and Conditions of Service of Govt. Employees Bill,2024.

Now therefore, in view of facts and circumstances and going through the Annexure P-2 of Writ the following petitioners only are hereby considered as regular employees of the state in the pay scale of Rs. 10300-34800+ 4200 Grade Pay + allowances as admissible from time to time from the date when they were initially appointed/joined on contract basis with all consequential benefits subject to final outcome of legal remedy and HP Recruitment and Conditions of Service of Govt. Employees Bill,2024:-
