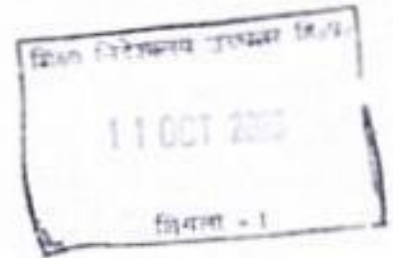

**ORDER**

**Whereas**, Smt. Bandana Devi, Lecturer (School-New) (History) was transferred from GSSS Halog (Dhami) (SML) to GSSS Girls Lakkar Bazar (SML) vice Smt. Anita Devi, Lecturer (School-New) (History) and vice versa vide this office order dated 25.09.2023. Against these orders Smt. Anita Devi filed CWP No. 7087/2023 before the Hon'ble Court. The case was finally listed before the Hon'ble Court on 28.09.2023 when the case was disposed of with the following directions:-


"Having taken note of the fact that the petitioner has completed more than two and half years at GSSS Girls Lakkar Bazar (Shimla), there appears to be no justification for this court to interface with the impugned transfer order dated 25.09.2023, whereby the petitioner has been ordered to be transferred from GSSS Girls Lakkar Bazar (Shimla) to GSSS Halog Dhami (Shimla) however, having taken note of the petitioner is due to retire within two years, present petition is disposed of with a direction to the petitioner to file a detailed representation to the respondents, within one week from today, praying therein for her adjustment/cancellation of impugned transfer order, on the ground of retirement within two years which shall be decided within a period of two weeks thereafter, by the competent authority, in terms of transfer policy/Comprehensive Guiding accommodate a person, who is due to retire within two years. Needless to say, authority concerned, shall afford opportunity of bearing to the petitioner and pass speaking order. However, it is directed that till the time, representation, if filed within one week from today, is decided, petitioner shall not be compelled to join to the transferred station".

**And whereas**, upon passing of above directions, petitioner, Smt. Anita Devi Lecturer (School-New) (History) submitted a representation and requested to adjust her either at GSSS Sanjauli / GSSS Lalpani GSSS Portmore/ GSSS Bhatakuffar/ GSSS Chotta Shimla, Distt. Shimla.

**And whereas**, as per the direction passed by the Hon'ble Court as above, the request of the petitioner has been considered and found that at present the post of Lecturer (History) is not lying vacant at proposed stations.

**Now therefore**, after taking into account the above facts and circumstances of the case, representation of petitioner is considered sympathetically and Smt. Anita Devi, Lecturer (School-New) (History) who is under orders of transfer from the GGSSS Lakkar Bazar (SML) to GSSS Halog Dhami (SML) is hereby adjusted in GSSS Boys Lalpani (SML) vice Sh. Divesh Kumar, Lecturer (School-New) (History) who is further transferred to GSSS Halog Dhami (Shimla) against vacancy with TTA/JT, as he is working in or around Shimla City since March 2019.

With these observations, representation stands disposed of.
