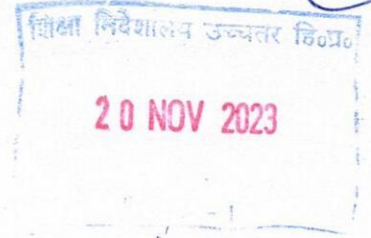

ORDER


Whereas, the petitioner namely Sh. Lalit Kumar, Lecturer (SN) History who is working at GSSS(B) Indora (Kangra) 08.06.2023 has filed CWP No. 7186/2023 titled as Lalit Kumar vs State of HP before the Hon'ble High Court seeking there in relief regarding his transfer.

And whereas, the representation from the petitioner has been received vide he has requested that however he has completed normal stay at GSSS Sarswati-Nagar (Shimla) but he was transferred to GSSS(B) Indora (Kangra) without consulting the Directorate of NCC. He has further requested that due to his adverse family circumstances he is not able to serve at GSSS(B) Indora (Kangra) and may be adjusted at GSSS Saraswatinagar(Shimla) or any other convenient station from where he can look after his family.

And whereas, while considering the representation of petitioner it was found that he had already completed his normal stay at GSSS Sarswati-Nagar(Shimla) as he was working there since 24.11.2018 and was transferred after completion of normal tenure. Whereas the matter of performing the duties of ANO(NCC) at GSSS Saraswati-Nagar(Shimla) he has been transferred to GSSS(B) Indora(Kangra) against the post of ANO (NCC) and he has already joined there on 08.06.2023 and having very short stay. And it is in the jurisdiction of the appointing/competent authority that after completion of normal tenure any official can be transferred to any where and any time as per requirement of the department. Moreover, he has not opted any other vacancy which is suitable for him. As he has already served at GSSS Sarswati-Nagar(Shimla) more than 4 ½ years hence, he should also serve the students in GSSS(B) Indora(Kangra).

Now therefore, after taking into account the above discussed detailed facts and circumstances, the request of the petitioner can not be acceded to. Hence, representation is considered and rejected. Accordingly petitioner will continue at the present place of posting. Hence, representation stands disposed of.
