**ORDER**

Whereas, the petitioner namely Sh. Raj Kumar, Lecturer (SN) History who was working at GSSS Nalti(Hamirpur) has been transferred to GSSS Pir-Saluhi(Kangra) vice Sh. Dinesh Kumar and vice versa on dated 30.09.2023 with the prior approval of the competent authority. Feeling aggrieved against these orders he has filed CWP No. 7674/2023 titled as Raj Kumar Vs State of HP before the Hon'ble High Court seeking there in relief. This petition was listed on dated 05.03.2023, when the Hon'ble Court has directed that :-

“Accordingly, the petition is disposed of with direction to the respondents to take a fresh decision in respect of transfer of the petitioner from GSSS Nalti(Hamirpur) to any other station after keeping in view the disability suffered by the petitioner and after hearing the petitioner on this aspect before effecting his transfer, if found necessary.”

And whereas, in compliance of Hon'ble High Court order dated 05.03.2024, the petitioner was called for personal hearing on 19.04.2024 and he was heard in person. During the course of hearing he has requested that his health condition is not good and he is suffering from Neurodegenerative disease and needs regular attendant with him. Hence, he may be allowed to continue his services at GSSS Nalti(Hamirpur) as he is also on verge of retirement within near about two years.

Now therefore, after taking into account the above discussed facts and circumstances of the case, the request of the petitioner is hereby considered in view of his health condition. Hence, in view his health condition and in compliance with the Hon'ble High Court order dated 05.03.2024, he is hereby retained at GSSS Nalti,Distt. Hamipur and Shri Dinesh Kumar, Lecturer (SN) History who is under orders of transfer from GSSS Pir-Saluhi(Kangra) to GSSS Nalti,Distt.Hamirpur is adjusted at GSSS Mair,Distt Hamirpur against vncancy.

Accordingly, representation stands disposed of.
