"ORDER"


Whereas the petitioner Sh. Sushil Kumar Katna, Lect./Lect.(SN) Physics who was under order of transfer from GSSS Sujanpur Tihra, Distt. Hamirpur to GSSS Kosri, Distt. Kangra vice Sh. Parveen Kumar, Lect./Lect.(SN) Physics & vice versa. Feeling aggrieved he filed CWP No 7944/2024 titled as Sushil Kumar Katna Vs State of H.P before the Hon'ble High Court. This petition was listed before Hon'ble High Court on dated 01.01.2025 when the same was finally disposed with the directions to respondents as under:-

Accordingly, this writ petition is disposed of by permitting the petitioner and his wife Smt. Vanita Kumari to make representation to respondent No. 2 within two weeks for their suitable adjustment in accordance with law. In case, such representation is so preferred, respondent No.2/ compendent authority shall consider and decide the same, in accordance with law nad applicable policy, within further period of two weeks. The order so passed shall also be communicated to the petitioner and his wife Smt. Vanita Kumari. Till such time, petitioner shall be permitted to continue at his present place of posting. It is, however, made clear that in case no such representation is preferred within the aforesaid period, the protection granted under order shall stand vacated.

The writ petition stands disposed of in the above terms, so also the pending miscellaneous application(s), if any.

And whereas upon passing of above directions, the representation of petitioner dated 15.02.2025 has been perused and examined and it has been observed that he has requested for his transfer either at any school near Hamirpur against longer stay of Lecturer working there or may be allow to continue at GSSS Sujanpur Tihra, (Hamirpur) till the completion of his normal tenure or may be adjusted at GSSS Alampur, Distt. Kangra against vacancy.

Now therefore, after taking into account the above discussed facts and circumstances of the case, a request of the petitioner has been considered, the transfer order earlier issued on dated 31.07.2024 is hereby cancelled & Sh. Sushil Kumar Katna, Lect./Lect.(SN) Physics is allowed to continue to serve at GSSS Sujanpur Tihra, Distt. Hamirpur. Accordingly his representation stand disposed of.
