"ORDER"

And whereas upon passing of above directions, the representation has received on dated 10.09.2024 has been perused and examined and it has been observed that she has requested for her transfer either at GSSS Bani,(Hamirpur)/ GSSS Barsar, (Hamirpur)/ GSSS Jaure Amb, (Hamirpur)/ GSSS Jhiraldi, (Hamirpur).

And whereas, as per transfer policy the incumbent posted at the stations of choice of the petitioner cannot be transferred in short stay. However she can be transferred any where against available vacancy if she opt for the same.

And whereas, now therefore, after taking into account the above discussed facts and circumstances of the case, the request of the petitioner has been considered and rejected to the extent that she may represent a fresh as and when the vacancy exists as per her choice of stations and same will be decided separately as per transfer policy. Accordingly her representation stand disposed of.
