**ORDER**



Whereas, Smt. Anuradha Katwal, Lecturer (English) was transferred from GSSS (G) Portmore (SML) to GSSS Jais (SML) vide this office order of even number dated 09.11.2023 vice Smt. Sarita Kumari, Lecturer (School-New) English and vice versa. Against these orders Smt. Anuradha Katwal, Lecturer (English) filed CWP No. 9041/2023 before the Hon'ble Court. The case was listed before the Hon'ble Court on 05.12.2023 when the Hon'ble Court has passed the following directions:-

"In view of the exigencies, so expressed, by the petitioner, we permit the petitioner to make a representation, indicating all hardships, including the hardships as referred to above, to the aforesaid respondent within two days from today; with further directions to the Respondent No.-2 Director of Higher Education, Himachal Pradesh, Shimla to examine the grievances/hardships and to redress the same and pass appropriate orders, after giving a personal hearing to the petitioner within three days thereafter. The action so taken, on the representation as above, be conveyed by way of affidavit/instructions on the next date of hearing."

And whereas, as per the direction passed by the Hon'ble High Court as above, she was called to appear in person on dated 11.12.2023. During the course of hearing, petitioner has requested to cancel her transfer order keeping in view of her adverse family circumstances.

Now therefore, a request of the petitioner has been considered and her orders from GSSS (G) Portmore (SML) to GSSS Jais (SML) is cancelled and Smt. Sarita Kumari, Lecturer (School-New) (English) who has already joined at GGSSS Portmore (SML) is also retained at GGSSS Portmore (SML) being large enrollment of students (i.e. 10+1=486 & 10+2=405) till the vacancy in the subject is available in some schools in local Shimla or till the rationalization of posts in various subjects is carried out. Pay lien of Smt. Sarita Kumari, Lecturer (School-New) is kept at GSSS Damyana (SML) against the vacant post of Lecturer (English). In addition to her regular academic activities, Smt. Sarita Kumari, Lecturer (School-New) English will also lead the career counseling and guidance cell of the school to guide the students regarding their various career options and also about the life skills and other activities.

With these observations, representation stands disposed of.
