Whereas the petitioner Sh. Kishor Kumar Jodhta Lect./Lect.(SN) Pol.

Science who is transferred from GSSS (G) Jubbal (Shimla) to GSSS Kaobil (Shimla) against vacancy in public interest dated 27.07.2024 Feeling aggrieved he filed CWP No 9087/2024 titled as Kishor Kumar Jodhta\_Vs State of H.P before the Hon'ble High Court. This petition was listed before Hon'ble High Court on dated 10.09.2024 when the same was finally disposed with the line of the High Court of the High Court.

when the same was finally disposed with the directions to respondents as under:-

"Reply to the petition has been filed. Having heard learned Counsel for the petitioner and taking into consideration the incumbency of the petitioner, the Court does not find any merit in the writ petition. According, this writ petition is disposed of with the direction that in the event of the petitioner filing a representation for his adjustment at some other station, within a period of one week from today, let an appropriate order be passed thereupon within a period of two week from the date fo receipt of the representation Till than, the petitioner shall not be forced to join the new station and he can avail the kind of leave due to him. Pending miscellaneous application(s) if any, also stand disposed of accordingly"

And whereas upon passing of above directions, the representation of petitioner dated 16.09.2024 has been perused and examined and it has been observed that he has requested for his adjustment to GSSS Mandhole(Shimla)/ GSSS Rathal(Shimla) against vacancy, or GGSSS Rohru, (Shimla)/ GSSS Samoli (Shimla) / GSSS Barla Kansa-Koti against the longer stayee

And whereas, while examined his representation it is found that at present the post of Lect. Pol. Science is lying vacant at GSSS Mandhole or GSSS Rathal Distt. Shimla and the students enrollment is very low in the stations which is given by the petitioner and a provision has been made by the Government to rationalize the such schools and another stations i.e GSSS (G) Rohru (Shimla) and GSSS Samoli (Shimla) has already been filled up and the incumbents who is posted in these schools is having short stay and there is no such name school i.e. GSSS Barla Kansa Koti in the State.

Now therefore, after taking into account the above discussed facts and circumstances of the case, the request of the petitioner has been considered and rejected on the ground that the petitioner served within the same constituency i.e. Jubbal-Kotkhai of Distt. Shimla since June, 2010 to July, 2024. Whereas being a state cadre employee he can be transferred anywhere in the State. Accodingly he is hereby adjusted at GSSS Pulbahal (Shimla) against vacancy, there is heavy enrolment of students, in which twenty seven (27) in plus one and twenty five (25) in plus two. Accordingly his representation stand disposed of.
