Subject:- Seeding of Aadhar with the Saving Bank Account of the Students to Release the Scholarship Amount through ABPS under Centre and State Sponsored Scholarship Schemes, of the Year 2022-23 & 2023-24, reg.

Sir,

In pursuance to Government of India, letter No.K-11036/4/2022-SCD-V dated 10-07-2023, received from Sh. Parveen Kumar Thind (IAS), Director, Ministry of Social Justice and Empowerment, Government of India, Shastri Bhawan, New Delhi, and in continuation to this Directorate letter of even number dated 15-05-2023 and dated 20-06-2023, on the above cited subject.

In this context, as you are aware that payment of scholarship amount under Centrally Sponsored and State Sponsored Scholarship Schemes are being released directly to the beneficiaries through Aadhar Based Payment System into the bank account of the students and for this purpose seeding of Aadhar with bank account of the beneficiary is mandatory. During the academic year 2022-23, under Pre-Matric Scholarship Scheme for the students of SC, 19813 scholarship applications and under Post-Matric Scholarship Scheme for SCs, 23450 scholarship applications were finally verified by the State of Himachal Pradesh. Till date, scholarship (State Share) under Pre-Matric Scholarship Scheme for the students of SC to 12161 beneficiaries and under Post-Matric Scholarship Scheme for the Students of SC to 17505 beneficiaries has been released by the implementing agency. The scholarship (State Share) could not be released to 7652 beneficiaries under Pre-Matric Scholarship Scheme for SCs and 6945 beneficiaries of the year 2022-23 due non-seeding of Aadhar Number with the bank account by these students.


The Ministry of Social Justice and Empowerment, Government of India, has taken serious view in the matter and it has been directed to provide necessary support to applicants whose bank accounts are not Aadhar seeded.

In view of above and to release the scholarship to the remaining beneficiaries of the year 2022-23 under Centrally and State Sponsored Scholarship Schemes, all the Vice-Chancellor/ Registrar of Government and Private Universities and Principal of Government and Private Degree Colleges/ Professional Colleges (within and outside of Himachal Pradesh where bonafide Himachali Students are studying) are **requested to check the status of Aadhar Seeding with bank accounts of the students to whom scholarship (State Share) has not been credited into the bank account of the students.** For this purpose, faculty members of the Universities / Colleges may be **asked to check the status of Aadhar Seeding with the bank account of the students on the official website of UIDAI.** If not done, **students can himself seed their bank account through Bharath Aadhar Seeding Enabled (BASE) developed by NPCI.**

The Principal/ Headmaster of all the Government & Pvt. Senior Secondary^{ry} High Schools in the State are **directed to ensure the Aadhar Seeding of the students to whom scholarship has not been received yet.** The faculty members of the schools may be **asked to provide the necessary support to the students to seed their bank account with Aadhar through Bharath Aadhar Seeding Enabled (BASE) developed by NPCI,** so that scholarship under various Centrally and State Sponsored Scholarship Schemes could be released to the remaining beneficiaries.

Further, in the Academic Year 2023-24 during verification at Institutional Level (L-I Level) kindly ensure that bank account number of the applicant is seeded with his/her Aadhar Number for timely disbursal of scholarship to all the applicants and to avoid unnecessary prolonging of scholarship disbursal process.

Your kind cooperation is solicited in the interest of the students and treat it utmost urgent please.


