Sub: Regarding transfers of ANOs (NCC) to Non-NCC Institutions.

In reference to letter No. EDUA-A009/13/2024-EDU-A-HPS (251409) dated 18.01.2025 received from the Secretary (Education) to the Govt. of Himachal Pradesh on the subject cited above and in continuation of this Directorate letter No. EDN-H(12)B(15)34/2023-ANO-III dated 23.10.2024 regarding transfer of ANOs (NCC)-Instructions thereof.

In this regard, the matter regarding transfer of ANOs (NCC) was taken up with the Govt. wherein it has been conveyed by the Secretary (Education) to the Govt. of HP vide letter dated 18.01.2025 that "the matter has been examined and decided to reiterate the earlier instructions issued by the Government from time to time regarding transfer of ANO. Further, advised that while making any transfer proposal in each proposal it may also be mentioned whether the teacher is ANO or not".

In this context, it is intimated that as per letter No.EDN-A-Chha(12)-1/2003 dated 12 April, 2003 ***"it has been decided by the Government that a NCC Trained Teacher (TGT/School Cadre Lecturer) may be posted/transferred in the institutions where the NCC activities are introduced/functioning. Such personnel may not be posted/transferred in the Govt. Institutions where the NCC activities are not functioning. This may be ensured that the NCC Trained Teachers only be posted/transferred to that institution where the NCC activities are introduced/functioning."*** Further, as per this Directorate letter No. EDN-H(I)B(2)B8/85-Vol-4 dated 01.05.2003 it has been directed that ***"For smooth functioning of NCC activities in the colleges/Schools, it has been desired by Hon'ble Chief Minister and Hon'ble Education Minister that ANOs (NCC) may not be transferred to non NCC institutions."***

Therefore, all concerned are requested/directed to adhere to these instructions and also ensure that the ANOs (NCC) are only be posted/transferred to that institution where the NCC activities are introduced/functioning.
