Whereas the petitioner Smt. Amita Devi, who has recently been promoted as Lect./Lect.(SN) Physics and under order of posting at GSSS Jambal, (KGR) and respondent Sh. Manoop Kumar has also been promoted as Lect./Lect.(SN) Physics & under order of posting at same station i.e GSSS Jambal, (KGR). Feeling aggrieved petitioner Smt. Amita Devi filed CWP No 3289/2023 titled as Amita Devi Vs State of H.P. before the Hon'ble High Court. This petition was listed before Hon'ble High Court on dated 13.07.2023 when the same was finally disposed with the directions to respondents as under:-

"i) Learned counsel for respondent No. 7, on instructions, submits that his client has no objection in case the petitioner is allowed to joined at GSSS Jambal, (KGR) and his client is permitted to file a representation for his transfer.

In the given facts and circumstances of the case, we deem it appropriate to dispose of the instant petition by permitting the petitioner to join at GSSS Jambal, (KGR) and at the same time to permit the private respondent to make a representation for his transfer, which is to be made one week from today and the same shall be considered and decided by the official respondents, within one week from the date of receipt of such representation.

Consequently, the impugned order dated 20.05.2023 (Annexure P-3), whereby the petitioner has been ordered to be transferred to GSSS Telka is quashed and set aside.

Pending applications, if any, also stand disposed of.

And whereas upon passing of above directions, the representation of respondent dated 17.07.2023 has been examined and it has been observed that he has requested for his transfer either at GSSS Khalet, Distt Kangra against vacancy being caused due to promotion of present incumbent.

Now therefore, after taking into account the above discussed facts and circumstances of the case, the request of the respondent has been considered and further adjusted at GSSS Khalet, Distt. Kangra against vacancy being caused due to promotion of present incumbent with the condition these order shall come into force on or after relieving of present incumbent from GSSS Khalet, (KGR) and the petitioner allowed to join at GSSS Jambal, (KGR). Accordingly his representation stand disposed of.
