TERMS AND CONDITIONS FOR DISPOSAL OF VEHICLE

- 1. The Director of Higher Education, H.P. Shimla-I intends to dispose of old/condemned articles on **äs is where is basis**".
- 2. Interested parties can participate in open bid to be held on 17-12-2024 at 3 PM at Directorate of Higher Education, H.P. Bidder shall deposit earnest money of Rs. 2000/- (Rs. Two Thousand Only) in the form of Demand Draft in favour of Director Higher Education Himachal Pradesh Shimla-1 in store branch of Directorate of Higher Education Shimla -1 on or before 17-12-2024 (up to 12 Noon) failing which bidder shall not be considered for participation in auction process to be held on the same day at 3 PM.
- **3.** The disposal of old/condemned articles shall be strictly on "AS IS WHERE IS BASIS" and no guarantee or certificate of its worthiness or quality will be given by the Department.
