**ORDER**

Whereas, the petitioner namely Sh.Mulakh Raj, Lecturer (SN) Hindi who is working at GSSS Killing (Mnd) w.e.f. 22.03.2023, has filed CWP No. 2339/2025 titled as Mulkh Raj vs State of HP before the Hon'ble High Court seeking there in relief regarding his transfer due to his family circumstances. This petition was listed on 14.02.2025 when the Hon'ble Court has given following directions:-

*(i). Respondent No.2 Director of Higher Education Shimla shall examine representation dated 24.12.2024 [Annexure P2] and shall pass appropriate orders thereon, in accordance with law, after affording personal hearing to petitioner within three weeks from today;*

*(ii). Needless to say, that this Court had not averted to the merits and rival claim in contentions in this case which are left upon for the authorities to be considered and examined in accordance with law.*


*In oforsaid terms, the instant writ petition as well as pending miscellaneous applications if any, also stand disposed off.*

And whereas, in compliance of Hon'ble High Court order dated 14.02.2025 the petitioner was called for personal hearing on 28.02.2025 and he was heard in person. During the course of hearing he has requested that due to his adverse family circumstances he is not able to serve at GSSS Killing (Mnd) . Hence, he may transferred from GSSS Killing (Mnd) to GSSS Baggi Distt Mandi against vacancy.

And whereas, as per the direction passed by the Hon'ble Court as above, the request of the petitioner has been considered and found that the petitioner has not completed his normal stay at present place of posting. Moreover he has served his entrie services in his home district and serving within distance of 30-35 KM since 2017 and at present there is compleat ban on transfer. So that at this moment the request of petition is considered and rejected.

Now therefore, after taking into account the above discussed detailed facts and circumstances. The request of the petitioner cannot be acceded to. Hence representation has been considered and rejected. Accordingly, petitioner will be continue at his present place of posting, representation stands disposed of.
