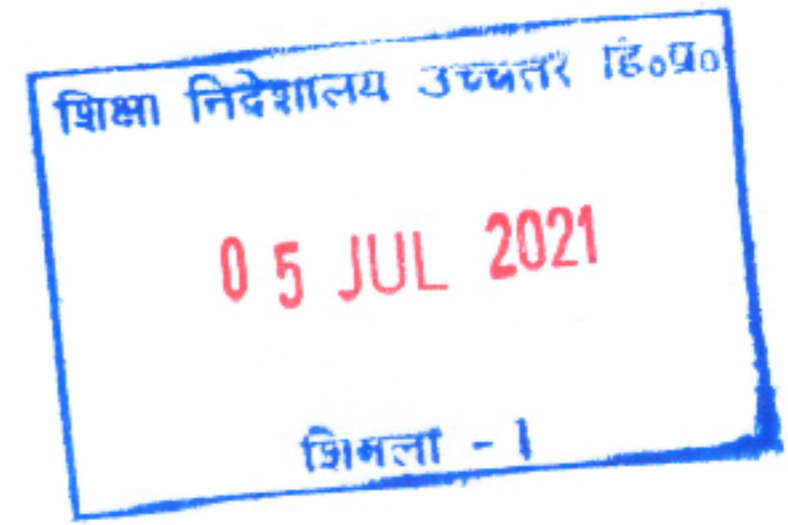

**ORDER**



**Whereas**, the petitioner namely Shri Chamel Singh, Clerk, while working as Clerk at BEEO Paonta-Sahib, Distt. Sirmour vide order dated 16-04-2021 was transferred to GSSS Timbi, Distt. Sirmour vice Shri Anil Kumar, Clerk and vice versa with TTA/JT with the prior approval of the competent authority.


**And whereas** feeling aggrieved against the said transfer order he filed CWP No. 2723/2021 in the Hon'ble High Court by alleging his adverse family circumstances. This CWP was disposed of on dated 30-04-2021 by the Hon'ble High Court with the following directions:-

**Consequently, this petition is disposed of with liberty to the petitioner to file a representation to the competent authority within a week, requesting therein to post him at a station of his choice or where post is lying vacant. Ordered accordingly. Representation, if any, filed by the petitioner within the stipulated time, shall be decided by the respondents/ competent authority expeditiously and preferably within a period of three weeks. Needless to say, opportunity of hearing shall be afforded to the petitioner and a speaking order shall be passed by the respondents. Till a decision is not made on the representation made by the petitioner by the competent authority, Annexure P-I shall not be given effect qua the petitioner. Liberty is also reserved to the petitioner to file appropriate proceedings before appropriate Forum, if he still remains aggrieved."**

**And whereas**, in pursuance to the order passed on dated 16-04-2021 by the Hon'ble High Court, a representation has been received from the petitioner and as per representation he has requested to adjust him at GSSS Gorkhuwala/BEEO Majra/BEEO Sataun/BEEO Paonta-Sahib, Distt. Sirmour due to his adverse family circumstances.

**Now, therefore**, after perusal of the record, the representation of the petitioner has been considered and the petitioner who is under orders of transfer from BEEO Paonta-Sahib to GSSS Timbi, Distt. Sirmour vice Shri Anil Kumar, Clerk is adjusted at BEEO Majra, Distt. Sirmour and Shri Anil Kumar, Clerk is adjusted/retained at BEEO Paonta-Sahib, Distt. Sirmour. With these observation the said representation is disposed of.
