

Terms of References	<p>1. Supply reduction:-</p> <ol style="list-style-type: none"> i. Coordination among the Drug Law Enforcement Agencies for enhancing enforcement activities. ii. Addressing the issue of involvement of foreigners in Drug trafficking. iii. Involvement of terrorists/insurgents/ LWE in Drug Trafficking activities. iv. Issue of illicit crop cultivation and the roles of various agencies including Agriculture/Veterinary Deptt. etc- Role of Alternative Development. v. Issue of dual use of chemical/ pharmaceutical Drugs and exploring the feasibility of their alternatives. <p>2. Demand Reduction</p> <ol style="list-style-type: none"> i. Taking up demand reduction activities by facilitating coordination between Central Agencies(MoSJE etc.) and State Agencies(Deptt. Of Social Welfare etc) for a wider outreach. ii. A psychological approach to treatment of drug abuse in addition to the traditional approach. ii.
