You are therefore, directed to ensure the implementation of this order in letter and spirit in all the educational institutions under your jurisdiction.



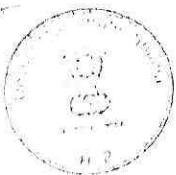

Order U/S 34 of National Disaster Management Act, 2005.

Whereas, the Chief Secretary-cum-Chairperson, SEC Himachal Pradesh vide Order No. Rev (DMC)(C)20-2/2020-COVID-19 dated 05-01-2021 has allowed certain relaxations in the restrictions imposed vide his previous order No. Rev (DMC)(C)20-2/2020-COVID-19 dated 31-12-2020.

And therefore, in continuation of this office order No. SML-ADM(L&O)/COVID-19-3503-20 dated 31-12-2020 I, Aditya Negi, IAS, District Magistrate, Shimla, in exercise of the power vested in me U/S 34 of the National Disaster Management Act 2005, do hereby order that following activities shall henceforth, be allowed in the district Shimla:-

1. There will be no restrictions regarding seating capacity in Inter-State as well as Intra State buses. However, all COVID-19 related safety protocols prescribed by the Transport Department shall be followed strictly.
2. The restrictions regarding gatherings etc. will not be applicable in regard to conduct of election related trainings subject to adherence to the SOPs issued by State Election Commission. However, it shall be mandatory for everyone to use mask and maintain proper social distance during the training.
3. The private/government institutions/centers imparting coaching for the competitive examinations can function subject to strict adherence to the SOPs issued by Education Department.



All other conditions mentioned in the order No. SML-ADM(L&O)/COVID-19-3503-20 dated 31-12-2020 shall remain the same.

This order shall come in force with immediate effect in the entire territorial jurisdiction of Shimla district and will remain in force till further orders.

Violation of this Order shall attract provisions of Section 51 to 60 of Disaster Management Act, 2005, Section 188, 269 & 270 of IPC and Section 111, 114 and 115 of HP Police Act, 2007 and the violators shall be prosecuted accordingly.

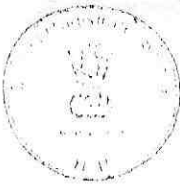
