Subject:- Seeding of Aadhar with the Saving Bank Account of the Students to Release the Scholarship Amount through ABPS under Centre and State Sponsored Scholarship Schemes, of the Year 2022-23 & 2023-24, reg.

Sir,

In compliance to GoHP No.EDUB-B015/4/2023 dated 14-07-2023, received from the Secretary (Education) to the Government of Himachal Pradesh and in continuation to this Directorate letter of even number dated 15-05-2023, dated 20-06-2023 and 17-07-2023, on the above cited subject. It is intimated that under Pre-Matric Scholarship Scheme for SC Students, 7269 students have not seeded their bank account with Aadhar Number. Similarly, under Post-Matric Scholarship Scheme for SC Students, 5822 students have not seeded their bank account with Aadhar Number. Due to non-seeding of bank account with Aadhar Number, scholarship (State Share) under centrally sponsored scholarship schemes could not be released to these students of the year 2022-23.

The Ministry of Social Justice and Empowerment, Government of India, has taken serious view in the matter and it has been directed to provide necessary support to applicants whose bank accounts are not Aadhar seeded.

In view of above, all the Vice-Chancellor/ Registrar of Government and Private Universities and Principal of Government and Private Degree Colleges/ Professional Colleges (within and outside of Himachal Pradesh where bonafide Himachali Students are studying) are **requested to check the status of Aadhar Seeding with bank accounts of the students to whom scholarship (State Share) has not been credited into the bank account of the students.** For this purpose, faculty members of the Universities / Colleges may be **asked to check the status of Aadhar Seeding with the bank account of the students on the official website of UIDAI.**

The Principal/ Headmaster of all the Government & Pvt. Senior Secondary / High Schools in the State are **directed to ensure the Aadhar Seeding of the**

students to whom scholarship has not been received yet. The faculty members of the schools may be asked to provide the necessary support to the students to seed their bank account with Aadhar Number, so that scholarship under various Centrally and State Sponsored Scholarship Schemes of the year 2022-23 could be released to the remaining students, accordingly.

Further, in the Academic Year 2023-24 during verification at Institutional Level (L-I Level) kindly ensure that bank account number of the applicant is seeded with his/her Aadhar Number for timely disbursal of scholarship to all the applicants and to avoid unnecessary prolonging of scholarship disbursal process.

The Deputy Director of Higher Education in Himachal Pradesh, are directed to ensure the above in all the Govt./Pvt. Sen. Sec./ High Schools in their respective District on or before 31-07-2023.

Most important, **the heads of the educational institutions will ensure to aware the students not to share their personal details i.e. Aadhar Number, Mobile Number, Bank Account Number and also not to provide their personal documents i.e. educational qualification certificates, income certificate, caste certificate, bonafide/domicile certificate etc. with any other educational institutes.** For any query, students can contact only through official telephone number i.e. **0177-2656622** or through **email:-nsphpsml@gmail.com** or the mobile numbers mentioned in the scheme ID on National Scholarship Portal.
