 - iv. States/UTs were requested to pair up each school in the State/UT with a specific school(s) of their paired States/UTs and exhibit this list in public domain. The links of this page may also be shared with the Department immediately.
- 3. The progress on the above action points may be shared by the States and UTs with the Department at ekbharatschools.gov@gmail.com by 31th May 2022.
