Subject: - Regarding grant of approved military services for the purpose of pay fixation in Education Department.

Sir,

I am directed to refer to your letter No. Shiksha-Him(19)B(4)-2/2011 Pay Fixation, dated 21.01.2020 on the subject cited above and to say that the matter was taken up with Department of Personnel who have advised as under:-

"Examined. As per amended Rule 5(I) of the Demobilized Armed Forces Personnel (Reservation) of Vacancies in Himachal State Non-Technical Services) Rules, 1972, the period of approved military service rendered after attaining the minimum age and qualification prescribed for appointment to the service concerned, by the candidate(s) appointed against reserved vacancy under the relevant rules, shall count towards fixation of pay in that service at the time of first civil appointment against reserved vacancy. Therefore, the past military service towards pay fixation cannot be allowed if such Ex-servicemen had not attained the minimum age and qualification at that time."

You, are therefore, requested to take further necessary action in the matter accordingly under intimation to this department.
