"Examined. As per amended Rule 5(1) of the Demobilized Armed Forces Personnel (Reservation) of Vacancies in Himachal State Non-Technical Services) Rules, 1972, the period of approved military service rendered after attaining the minimum age and qualification prescribed for appointment to the service concerned, by the candidate(s) appointed against reserved vacancy under the relevant rules, shall count towards fixation of pay in that service at the time of first civil appointment against reserved vacancy. Therefore, the past military service towards pay fixation cannot be allowed if such Ex-servicemen had not attained the minimum age and qualification at that time."
