Particulars of Clerks/Jr. Asstts. for promotion to the post of Senior Assistant.

On the subject cited above, it is informed that as per existing Common R&P Rules for promotion to the post of Senior Assistant notified by the Govt. vide their Notification No. Per(AP)-C-A(3)-7/2010, dated 3rd August, 2011, all such incumbents will be eligible for promotion to the post of Senior Assistant only if, they possess the minimum educational qualification of 10+2 and qualified type test. Institution have been issued with regard to promotion orders of Senior Assistant on the basis of their seniority in the cadre of Clerk with imposed the condition in the promotion orders. But, it has came to the notice of the department that some Head of the offices/institutions are ignoring the said conditions and they are relieving the concerned officials to their new place of posting without examining the imposed conditions as mentioned above.

Now, it has been decided by the department that in future before making promotion, it will be the personal responsibility of the Head of the office/institution that the desired particulars of the concerned officials should be checked properly from the service book as well as from original record and same information should be forwarded to this Directorate on prescribed proforma enclosed herewith through proper channel as and when required by the department, failing which no promotion orders will be issued of the concerned officials.

directed to You are, therefore, circulate the said letter to all the institutions/offices(Hr./Ele. both) situated in your distt, for strict compliance and supply the particulars of the concerned officials shown in the list as well as leftout cases, if any, to this Directorate on prescribed proforma alongwith photo copies of other documents, within one month from the issuance of this letter, so that promotion orders of the concerned officials could be issued accordingly in future.
