
In continuation to this office letter of even number dated 30.5.2013 & 17.02.2014 regarding Guidelines for implementation of IT-Education in Government schools.

The department is running/implementing various online IT applications successfully in the state and likely to add/introduce some more IT applications very shortly to improve the efficiency of the Department. But, it is a matter of great concern that despite of giving direction at various levels to ensure internet connectivity in IT & ICT Labs in the schools, the Heads/Principals have not provided internet connectivity in the schools.

Therefore, all the Principals/Head of the schools are again directed to ensure internet connectivity in the school for the use of students as well as official concerned of the school for above mentioned online application. The internet connection can be procured from any of the PLAN specified & approved by Department of IT, H.P. as per requirement/availability (copy of the PLAN attached).

The Principals/Head of the schools may utilize RMSA fund or any other funds available, till the arrangement of special funds for this purpose.

These directions may be adhered strictly and action taken report may be sent to the DDHE concerned with a copy to the undersigned through email.

In this regard, it is submitted that DIT has approved Data Card
Plan for all the department so that the Government Employees may have more
options to choose Data Card Plan according to the availability of Telecom Service
Provider and its signal strength. The officers/officials (including retired employees) of
various establishment can opt the Data Card Plan as per the

for getting printed copy of the Application Form & Data/Broadband Connection.
