This is with reference to letter No.EDN(D)1-33/2016 dated 27-02-2016 & letter of even number dated 09-03-2016, received from the Additional Chief Secretary (Education) to the Government of Himachal Pradesh, on the subject cited above.

In this regard, you are also directed to ensure the following in the school to prevent the jaundice and other water borne diseases:-

- 1. The Registrar/ Principal of the concerned University/ College will ensure to empty their water storage tanks and also to clean the same with bleaching powder (50 gms/ 1000 ltr.) for 30 minutes. Water should be filled after cleaning the tank twice with fresh water. Use tap water after a gap of atleast one day. These water tanks should be regularly cleaned after 2-3 montsh and properly treated water fir for dinking be supplied.
- The Registrar/Principal of the concerned University/ College will ensure to provide pure and safe drinking water to the students and staff in terms of provision contained in the "Water (Prevention and Control of Pollution) Act, 1974".

- 3. The Registrar/Principal of the concerned University/College will remain in touch with Irrigation & Public Health Department and all other concerned Departments, so that pure and safe drinking water is made available to the students in the State as per the directions of the Hon'ble High Court of Himachal Pradesh.
- The Registrar/Principal of the concerned University/College will also ensure to follow all the provisions contained in the Food Safety and Standards Act, 2006
- The water filters (preferably Ultraviolet) be made available in the school to the students as well as staff.
- 6. The Registrar/Principal of the concerned University/College must ensure that sufficient pure and safe drinking water in terms of the provision contained in the Water (Prevention and Control of Pollution) Act, 1974, is available to every student and staff. Instructions/ directions in this regard may be given regularly also.
