to submit here that vide order dated 7-7-2017, following directions were given by this Hon'ble High Court:-

- i. State Government shall constitute a Nodal Agency to strictly monitor the implementation of drug trafficking laws in the State by involving all stakeholders, agencies and departments of Government including Department of Health and Medicine, Social Welfare, Home and NGO's etc;
- ii. State Government shall issue directions to all educational institutions including private educational institutions to boldly display in their premises the ill effects of drug abuse so as to educate the children of the ill effects of the same;
- iii. State shall ensure that all hospitals in the State including the private hospitals are well equipped with dissemination of knowledge with regard to addiction medicine as well as specialist doctors on the subject.
- iv. State shall inform before the next date of hearing as to how many drug rehabilitation centers are presently running in the State of Himachal Pradesh along with all infrastructural details including the number of patients (not their personal details) who have been treated in said rehabilitation centers;
- v. State shall also inform before the next date of hearing number of specialist doctors available in the State who are trained to exclusively treat patients of drug abuse;
- vi. State shall also inform the Court as to whether any rehabilitation policy of drug addicts exist in the State of Himachal Pradesh and if not then how soon the State can have such policy in place. List on 8.8.2017.
